

Safe Management Measures for Funeral Events

On 24 March 2021, the Multi-Ministry Taskforce announced that more activities would be allowed to resume as Singapore moves towards further easing of community measures. This document provides the conditions under which the Funeral Director or any person engaged to organise the funeral event, or premises owner of the venue where the funeral event is held when no person is engaged to organise the event, are permitted to resume more activities during Phase Three.

Limits on Number of Attendees

1. From 24 April 2021, attendees at wakes and funerals **on the day of the burial/cremation only**, including foot processions, shall be kept to 50 persons or fewer at any one time, depending on the safe capacity of the venue, whichever is lower. The cap for other days of the wake remains at 30 attendees at any one time. Pre-event testing is not required.
2. Burials and cremations shall be attended by not more than 50 persons in total. NEA will issue 50 entry passes for each cremation or burial application at the government-managed facilities.
3. Religious workers, funerary staff and persons involved in the conduct of live instrumental music should be kept to a minimum.

Group Size and Safe Distancing

4. All attendees at funeral wakes, foot processions, burials and cremations must wear a mask. The prevailing group size of no more than eight pax applies and there should not be mixing between groups. Please ensure that a safe distance of at least one metre is maintained between individuals and/or groups.
5. Where seating at a table is provided, individuals must be seated at least one metre away from others at all times. Tables and chairs must be arranged such that each table can accommodate not more than eight individuals seated at the table or not more than eight individuals in each group separated by a space of at least one metre. There should be no mixing between groups.

Food and Beverage

6. Attendees of funeral events should minimize their interaction with fellow attendees and leave the premises immediately after the event. No buffet set-up or reception with food and drinks is allowed. Individually packed drinks (i.e. bottled/packet drink) or individually packed tidbits (e.g. peanuts, melon seeds) may be provided, but masks must be worn at all times except when the individual

is drinking or eating. Funeral Directors are advised to put up signages on the tables to remind attendees that, except when the individual is drinking or eating, masks must be worn at all times. **There should be strictly no sharing of drinks/titbits.**

Individually packed bento boxes may be supplied to family members of the deceased who keep vigil for the duration of the funeral wake, and need to consume food at the premises. However, they should not interact with the other attendees when consuming their meals, and should consume their meals away from guests present at the funeral/wake event.

Live Performances

7. Live instrumental music (non-wind) will be allowed at funeral events. The persons involved in the conduct of live instrumental music must wear a mask and should minimise movement to ensure that the one metre safe distance can be adhered to at all times. They are not to participate in the foot procession. No other performances (e.g. singing, dance, variety act) are allowed and there should be no sharing of equipment (e.g. musical instruments, microphones, props).
8. Hearse escort party is not allowed during the funeral event.
9. Religious workers involved in the conduct of the religious rites (e.g. preachers, prayer leader, scripture reader), may wear a face shield in place of face mask, when performing their speaking duties (i.e. preach, chanting of prayers) at funeral wakes and funeral services (i.e. cremation or burial services). They should largely remain at the spot from which they are speaking and must be at least one metre away from any other individual.

Temperature Screening

10. Temperature screening is required for every individual entering the funeral event space and any person who is unwell must be turned away.

SafeEntry

11. SafeEntry check-in is required for funeral events and funeral parlours with wake halls. Visitors must perform SafeEntry check-in, via any methods that are presently regarded as the appropriate procedure and control to enable or facilitate contact tracing (e.g. TraceTogether app or TraceTogether token).
12. From 19 April 2021, funeral parlours with wake halls are required to deploy SafeEntry Gateway as an additional SafeEntry check-in method. The SafeEntry Gateway enables contactless detection of both the TraceTogether App and Token, and serves as an additional means of SE check-in that is quicker and

13. Discourage vulnerable persons, such as the elderly, from attending these events to protect their health and consider alternative solutions for them, such as live video screening instead.
